

Eugene Kinney Stauffer, Sr. Family Tree

The 1795 South of Green River Act by the Kentucky General Assembly might have been the catalyst that motivated Benjamin to move west because it allowed non-veterans to settle in the south-central Military District of Kentucky previously reserved for Revolutionary War veterans. Settlers who were 21 years old (later lowered to 18) and had settled on land in the county were entitled to purchase up to 400 acres from the county. Benjamin's initial land acquisitions lead one to believe that he first settled along the Big Difficult Creek a few miles east of present day Scottsville. After a few years he seems to have left his farm operations to his son, William, while he developed another farm in the northeast corner of Barren County in the Munfordville/Canmer area on the south side of the Green River. From land grants records and his will, it is apparent that Benjamin owned a variety of properties during his life in Kentucky, nearly all of which he left to his children.

Lucy had 17 children (10 boys and 7 girls) – only the names given in his will are listed below. Most, if not all, were born in Culpeper County, Virginia. The poor woman was pregnant nearly continuously from age 20 to 55; a 35-year period. Several of the older children were married by the time they moved to Kentucky, and two died before 1817 when their father died.

Benjamin wrote his will on October 27, 1817, in Barren County, then died sometime before the Barren County December 1817 Court met, likely in November. He was 73 years old. The December Court ordered witnesses to appear at the January Court to swear to the authenticity of the will. Because some witnesses could not attend the January Court, the court issued a continuance until February 16, 1818, at which time the will was approved. Benjamin made the following bequeathments, much in the form of land, slaves, and horses that he had previously given to his children 15-20 years earlier:
